From the East - Take Hwy 412 to the exit for 30th Street/NOC. At the Stop sign turn Right (north). Go approximately 4 miles and follow the curve to the left. You are now on Willow Street. Go to the 4-way stop at 4th St and turn rt. (north). Go to Purdue St (about 2 miles) - turn left (W) the Expo Center is on the left (south side).

From the South on Hwy 81 - You will go through several small towns - DO NOT SPEED through them at any time - You will see a sign on the right that says "Welcome to Enid" - continue on Hwy 81 (Van Buren St) approx. 10 mi. to Purdue Street - turn right (east) at the Stop Light and the Expo Center is 1/2 mile on the right (south side)

From the West on Hwy 412 - Stay on Hwy 412 (W Owen K Garriott) to the Intersection of Hwy 412 & 81 (Garriott & Van Buren). Turn left (north) and follow above directions for those coming from the south on Hwy 81.

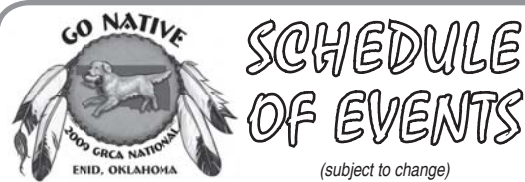
