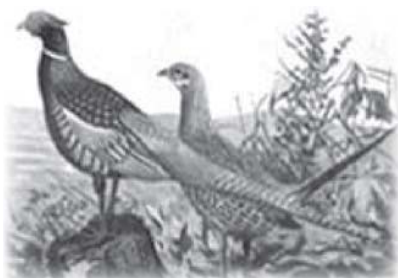
**IMPORTANT NOTICE:** As of March 31, 2009 - The Comfort Inn has changed to a NO PETS policy.
