**ENTRY INFORMATION**

- **Limit: 10 entries per envelope. One entry = one dog. Envelopes containing more than 10 entries will be returned.**
- Owners are responsible for ensuring that entry forms are completed IN FULL. Entries submitted without ALL information will be returned as invalid.
- All entries must be submitted on official AKC agility entry forms, one dog per entry form. Photocopies of entry form will be accepted only if legible and official AKC size.
- Entries will not be accepted without signature, fees and reverse of entry form with agreement signed, nor will credit cards or faxed entries be accepted.
- Returned checks do not constitute a valid entry; no refund for duplicate entries.
- Bitches in season are not permitted in the trial; Wheatland Golden Retriever Club of Wichita will refund all but \$10 for bitches who come in season. The Trial Secretary must have written veterinary notice no later than 30 minutes before the start of the trial. All refunds will be mailed after the trial.

- ✿ A Sportsman Exhibitor does not enter or exhibit under a judge where there is evidence that the judge's placements may be based on something other than the merits of the dogs.
- ✿ A Sportsman Exhibitor does not compromise the impartiality of a judge.
- ✿ A Sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- ✿ A Sportsman finds that vigorous competition and civility are not inconsistent and is able to appreciate the merit of his or her competition and the effort of competitors.
- ✿ A Sportsman does not take personal advantage of positions offered or bestowed upon him or her.
- ✿ A Sportsman always considers as paramount, the welfare of his or her dogs.
- ✿ A Sportsman will not embarrass the sport, the American Kennel Club, nor him or herself, while taking part in the sport.

## AWARDS

**Ribbons/Rosettes:** Rosettes will be awarded to the 1<sup>st</sup> through 4<sup>th</sup> place dog in each class in each jump height. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement ribbons. We will have special New Title rosettes along with rosettes for those earning a MACH or PAX (also includes a MACH/PAX pole).

## REFUND POLICY

- Entry fees will be refunded if an entry is pulled before the closing date and time.
- No refunds will be made for any entry pulled after the closing date.
- of Wichita Golden Retriever Club will provide full refunds less \$10 for bitches in season. Veterinary verification in writing must be submitted to the Trial Secretary no later than 30 minutes before the start of the trials. Refunds will be mailed after the trial.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Trial Committee, is ineligible to compete due to being entered incorrectly or if a trial cannot open or be completed.

## EXHIBITOR INFORMATION

- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.
- Running order will be determined by computer-generated random draw. Handlers with multiple dogs in one class will have those dogs separated as much as possible.
- All dogs present *must* be on leash or confined in crates when not being judged.
- Puppies under six months of age are NOT allowed in the trial site.
- Exhibitors may wear shirts or insignia of their training group.
- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all the obstacles safely.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms; illegible or incomplete entries will not be accepted.

## AREA MOTEL LISTING

### TRIAL HOURS

The trial grounds will be open at 6:30 am. Self-service check-in will begin at 7 am, and judging will begin no earlier than 8 a.m. Exact running order will be determined after entries close and will be provided in the Judging Program.

### ELIGIBILITY

This trial is open to all Golden Retrievers (meaning either sex) 15 months of age or older that are registered with the AKC or that have AKC Limited Registration, Indefinite Listing Privileges (ILP), Purebred Alternate Listing (PAL). Bitches in season, aggressive dogs, dogs that are blind or deaf or suffering from any deformity, injury or illness that may affect their physical or mental performance may not be entered.

### CLASSES & TITLES OFFERED

Please see the AKC Regulations for Agility Trials for current class descriptions. Dogs must be entered only in Regular Classes or Preferred Classes with no cross-over between classes allowed at the same set of trials.

### DIRECTIONS TO THE TRIAL SITE

- North or South on I-35: Merge onto US-412 West (Exit 194B) toward Enid; Turn right (north) onto South Van Buren Street/US-60 East/US-81 North; Turn right onto Purdue Avenue and continue to the Garfield County Fairgrounds; follow directional signs at the fairgrounds to the Chisholm Trail Expo Center Pavilion; **NOTE:** Additional maps will be supplied with the Judging Program

### SPECIAL NOTE ON JUMP HEIGHT CARDS – PLEASE READ!

All agility dogs are required to have an Official Jump Height Card/Valid yellow form and exhibitors must be able to present it prior to running their dog(s) in any class or at any time during the trial upon request whether or not they have sent a copy of such with their entry. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured or wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog *before* its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

### ONLINE ENTRIES

The Trial Secretary **does not** accept electronically-submitted entries from any online entry system. Entries filled out using an online entry system must be printed and mailed to the Trial Secretary's post office address supplied elsewhere in this premium.

### OBSTACLES

All obstacles used conform to the requirements in the most current issue of the AKC Rules and Regulations Applying to Agility.

### ENTRY CONFIRMATIONS & JUDGING PROGRAMS

An initial email confirmation is sent only if the email address is *legibly printed* on the entry form. If you cannot receive a Microsoft Word text file, or if you do not check your email, do NOT include your email address. Printed confirmations and Judging Programs are mailed to exhibitors without email addresses. Please contact the Trial Secretary by phone or email to report any errors. **Correct AKC registration # or ILP # is crucial.**

**NOTE:** If you have a spam filter in place on your email account, please add the trial secretary's email address to your accepted address list. If you prefer NOT to add the address, then do **NOT** provide an email address; your confirmation will be mailed.

The final confirmation and Judging Program are emailed or mailed to those without email to the owner's email/postal address. If you want this information sent to the handler (if different from owner), please specify on your entry and provide the correct email address. If any exhibitor does not receive the Judging Program within five (5) days of the trial, please contact the Trial Secretary.

### HEIGHT DIVISIONS

Owners are responsible for entering the proper height division. Exhibitors may choose to enter their dogs in a higher height division than required by AKC, but not in a height division lower than the AKC mandated height. Dogs in the Preferred Classes **MUST** jump their preferred class jump height. They may not enter in a higher jump class.
